**Family Stewardship Agreement**

- Each family is responsible for either 20 hours of documented volunteer hours per school year or may choose to pay a lump sum of \$200.00. (\$10.00/hr.)
- The Stewardship year for the 2018-2019 school year will start after May 16, 2018, and run through May 15, 2019. This allows families to volunteer time during the summer.
- Stewardship hours will be invoiced in May. All volunteer hours turned into the office by May 15<sup>th</sup> will be credited from the total amount prior to this billing. Any hours turned in after May 15<sup>th</sup> may be held until the next school year.

**Non-Discrimination Policy**

**Financial Responsibility:**

I/We hereby commit to pay all financial obligations to the school on or before the first of each month. I/We understand that:

- Registration fees are **not** refundable.
- Annual Technology fee per student is payable with the **first** tuition payment.
- Field trip fees are due with or before the **first** tuition payment.
- We understand that we must set up and maintain an account with FACTS Management prior to Enrollment.
- We understand that tuition must be paid in one of the following ways: **Choose one**
  - Payment in full on or before June 25, 2018 according to FACTS Management agreement.
  - Monthly payment plan according to FACTS Management agreement.
- There is a service fee for all NSF returned items.
- If payments are **not** made per agreement:
  - Financial Assistance (if applicable) may be withdrawn.
  - My child may be withdrawn on the first of the month if the previous month's financial obligations have not been met and if arrangements have not been made with the administration.
  - A late fee of \$25 may be assessed.
  - I understand official report cards and/or diplomas will be held, and requests for official transcripts or transfer of records may not be honored for students whose accounts are past due.
  - If collections action are necessary, I agree to pay collection fees and reasonable attorney fees. The venue would be Thurston County.
- There will be a replacement cost charged for any lost and/or damaged textbooks.
- I have read, understand and agree to comply with the Family Stewardship Agreement.
- The School lunch program is **prepaid and ordered by the monthly deadline**.
- LATE PICK UP FEE— When I do not pick up my child by 6:00 pm a late fee will be incurred as detailed in the Parent/Student Handbook.
